

# Privacy Policy

Farah Aina Binti Kamaludin("we", "us", or "our" ) cares about privacy. We believe that privacy is a fundamental right for all individuals. This Privacy Policy describes our policies and procedures on the collection, use and disclosure of your information when you use this Fancy Wall: Art Wallpaper ("App" or "Service") and tells you about your privacy rights and how the law protects you.

## ● Personal information we collect

We may collect the following information, including personal information from and about you:

- (1) Data obtained from third-party partners such as marketing platforms or social media. If you register through your social platform credentials, we may collect some personal data through your social platform account.
- (2) Data automatically collected when you use our services, including but not limited to Mac-Address, device identifiers (such as IDFA, IDFV for Android, GAID for IOS), device model, device brand, device language, device network type, screen resolution, usage log, etc.
- (3) Personal data you actively provide to us, including but not limited to name, email-address, account information for paying subscription fees, etc.

## ● How we use this information

We may use personal data for the following purposes:

- (1) To provide and maintain the App, including to monitor the usage of our Service.
- (2) To contact you, by email or other equivalent forms of electronic communication.
- (3) To provide you with news and general information about other services.
- (4) To manage your requests to us.
- (5) For other purposes: we may use your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns and to evaluate and improve the App, services and your experience.

## ● Who we share this information with

We do not sell or otherwise disclose personal information we collect about you.

We may share your personal information:

- (1) With our partners and third-party service providers. We authorize these service providers to use or disclose the information only as necessary to perform services on our behalf.
- (2) To third-party advertising companies for the marketing and advertising purposes.
- (3) To any competent law enforcement body, regulatory, government agency, court or other third party where we believe disclosure is necessary (i) as a matter of applicable law or regulation, (ii) to exercise, establish or defend our legal rights, (iii) to protect your vital interests or those of any other person or (iv) for any of the compliance and protection purposes outlined above.

#### ● **Children**

We do not knowingly collect, maintain, or use personal information from children under 13 years of age, and no part of the App is directed to children under the age of 13. If you learn that your child has provided us with personal information without your consent, you may alert us via email. If we learn that we have collected any personal information from children under 13, we will promptly take steps to delete such information and ban the child's access.

#### ● **How we secure your information**

We care about the security of your personal information, and take steps including implementing appropriate technical and organizational measures to ensure that your personal information is treated securely and in accordance with this Policy. The measures we use are designed to provide a level of security appropriate to the risk of processing your personal information.

#### ● **How long we retain your information**

We will retain your personal information only for as long as is necessary for the purposes set out in this Policy. We will retain and use your personal information to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. When we have no ongoing legitimate business need to process your personal information, we will either delete or anonymize it.

#### ● **Third party links**

The App may provide links to other sites on the Internet for your convenience. These other sites are maintained by third parties over which we exercise no control. The appearance of any such third party links (provided by us or by a third party) is not intended to endorse any particular company or product. If you decide to access any of the third party sites linked to the App, you do so entirely at your own risk and we recommend you read their privacy policies carefully.
